



## Food & Farm Scorecard 2022

The California Food and Farming Network (CFFN) envisions an inclusive, equitable, and ecologically regenerative food and farming system that has recognized and repaired injustices to Black, Indigenous and People of Color workers, producers and communities, and which generates healthy, affordable, accessible, nutritious and culturally appropriate food and other agricultural products.

CFFN is a network of almost [50 members](#) across the state, building a movement centered on racial equity to transform the food and farming system through state policies.

# A Decade of Food & Farming & 2022 Analysis

For 10 years this community has been tracking collective food and farming legislation and asking legislators to vote for an equitable food system. While there is still much to do, we've seen a number of policies transform our food and farming system. Many of these policies were achieved incrementally over a number of years, building momentum, bi-partisan support, and power.

For example, the achievement of School Meals for All in 2021 (with further investments in 2022) had years of foundational policies preceding it<sup>1</sup>. And there is still more in front of us, such as expanding this value to preschool-aged children and when school is out, two concepts that did not pass this year.

Some of our 2022 priorities are in the middle of their incremental progress towards systems change and require more work to fully realize, such as fully funding Food4All and establishing a Health Equity and Racial Justice Fund. The former having been modeled on proven concepts such as Medi-Cal expansion for all regardless of immigration status. We've seen new agricultural programs, from the climate-smart agriculture Healthy Soils Program in 2016 to the start of an Organic Transition program in this legislative cycle. And, in recent years there have been small shifts striving to ensure equitable access to these programs for Black, Indigenous and People of Color (BIPOC) food producers and land stewards, while expanding programmatic costs to include the time and skills needed for producers to execute these practices.

Other historic policies have established state values, such as the Farmer Equity Act of 2017, while still more have corrected decades of inequities, such as Farmworker Overtime in 2016. This year we saw the establishment of the California Agricultural Land Equity Task Force as a foundational step to recognize and transform generations of oppressive ag land discrimination. We need all of these tactics to change broken systems and address structural inequities.

**2022 continued to see some substantial investments in this work, and yet 11 priority items across all food & farming sectors failed or were not fully achieved this year, particularly within our priority farmworker legislation.**

**As we head into 2023 with a projected budget deficit and a commitment to building a just and equitable food system in which Californians can thrive, it's crucial that we do not move backwards and that we maintain momentum toward a thriving food system that can have a transformative impact on our state.**

# Regional Food System Resilience

## Wins

### Food & Farm Resilience Budget Items - Support

Farm to School Incubator Grant Program (\$60 million) and Healthy Refrigeration Program (\$10 million)

*Achieved in the budget*

## Partial Wins

### SB 907 (Pan) - Local Equitable Access to Food (LEAF) - Support

Will provide non-competitive grant funding to every certified farmers' market and farmers' market operated on sovereign tribal land in California in order to offer high-quality CalFresh/EBT access.

*Passed by the Legislature and signed by the Governor, but not funded.*

## Losses

### AB 2680 (Arambula) Community Health Navigators - Support [Ally Bill]

Would have invested in community-driven approaches to outreach, enrollment, retention and utilization of Californians who are eligible for Medi-Cal and the Medi-Cal Access Program. Health equity is not separate from the inequities present in our food system where BIPOC communities have disproportionately higher rates of diet-related disease and less access to healthcare.

*Died, inactive on Senate Floor*

### Health Equity and Racial Justice Fund - Support

Would have supported transformative community-driven change to reduce health inequities and advance racial justice by providing direct funding to community-based organizations, clinics and tribal organizations to address the social determinants of health.

*Died, included in the Legislature's budget but not supported by the Governor*

**Food sovereignty:** All people have the right to healthy and culturally appropriate food produced through ecologically sound methods, and to define and prosper in their own food and agriculture systems.

**Shared Economic Prosperity:** All people have equitable opportunity to fully participate and build wealth in the food and farming system, contributing their food and ag cultures, knowledge and skills to strengthen and diversify opportunities and build resilience for all.

# Farmworker and Food Chain Worker Advancement

## Wins

### Food & Farm Resilience Budget Items - Support

Joe Serna, Jr. Farmworker Housing Grant Program (\$50 million) and Low-Income Home Weatherization for Farmworker Housing (\$15 million)

*Achieved in the budget*

## Losses

### AB 2082 (R. Rivas) Farmworker Indigenous Language Outreach Program - Support

Would have required Cal/OSHA to directly contract with community-based organizations in three counties to provide outreach services for farmworkers who speak indigenous languages.

*Held in Assembly Appropriations Committee*

### AB 2243 (E. Garcia) Ultra High Heat Illness - Oppose

Originally required the development of updated workplace safety standards for ultra high heat (105 degrees) and particulate matter for outdoor workers, including work breaks every hour, accessible cool water, shade structures, and increased employer monitoring symptoms of heat related illness. Last minute amendments removed the development of updated workplace safety standards for the ultra high heat standard and also weakened existing Cal/OSHA regulations related to masks during hazardous smoke events, thus moving CFFN's Farmworker Advocacy Working Group to an oppose position.

*Passed by the legislature and signed by the Governor*

### AB 2538 (R. Rivas) Wildfire Smoke Notification - No Position

Would have required the state warning center to include targeted alerts for public health dangers, including smoke from wildfires. CFFN's Farmworker Advocacy Working Group was working with the author's office to amend this bill to make sure that it targeted the needs of agricultural workers, who are especially vulnerable to hazardous wildfire smoke and had not yet taken a position.

*Held in Assembly Appropriations Committee*

### AB 2847 (E. Garcia) Unemployment: Excluded Workers Pilot Program - Support [Ally Bill]

Would have established a pilot program in the Labor and Workforce Development Agency to provide income assistance to unemployed excluded workers who are not eligible for the state or federal benefits administered by the Employment Development Department due to immigration status.

*Vetoed by the Governor*

**Empowered Workers:** Workers are respected and valued as essential to the survival and health of our communities, share in the wealth of their labor, have the power to shape their working conditions and lives, and the opportunity to become owners or prosper within the food system.

# Improved Access to Healthy Food

## Partial Win

### Food4All (Hurtado, Santiago) Budget Item - Support

Builds on policy passed in 2021 that modernizes the California Food Assistance Program to provide food assistance benefits to households who are currently ineligible solely due to their immigration status. This policy received funding in the FY 2022-23 budget for ages 55 and up.

*Achieved in the budget, but program is not yet fully funded to cover all eligible undocumented individuals*

## Losses

### AB 2153 (Arambula) CA Fruit and Veggie EBT Expansion Program - Support

Would have expanded the California Fruit and Vegetable EBT Pilot Project established in 2018 and expanded the availability and diversity of retail locations where CalFresh participants earn fruit and vegetable supplemental benefits.

*Held in Assembly Appropriations Committee*

### SB 364 (Skinner) Better Out of School Time (BOOST) Nutrition Program - Support

Would have built on Free Meals for All funded FY 21-22 budget by taking additional actions to address child hunger, including creating the Better Out of School Time (BOOST) Nutrition program to fight hunger when schools are closed, updating school data collection and maximizing P-EBT benefits.

*Held in Assembly Appropriations Committee*

### SB 1481 (Becker) Food With Care: Fair Pay for Child Care Providers. Free Meals for All Kids - Support

Would have ended the racist "pay penalty" for family child care home providers and would have ensured that child care providers are fairly compensated for meal service.

*Held in Assembly Appropriations Committee*

**Food is a Human Right:** All communities have access to the nutritious, affordable, culturally appropriate, and traditional food they need to thrive.

**Ecological Health:** Our food and farming system is rooted in agroecological systems determined by impacted communities, shifting power away from corporate agribusiness. This means honoring Indigenous and cultural practices, and farming in harmony with nature so that people and the land are nourished and healed.

# Agroecological Farming

## Wins

### Agricultural Land Equity Task Force (Aguilar-Curry) Budget Item - Support

Establishes an Agricultural Land Equity Task Force at the Strategic Growth Council to develop recommendations to equitably increase access to agricultural land for food production and traditional tribal agricultural uses.

*Achieved in the budget*

### Drought Relief for Small Farmers Budget Items - Support

- Invests \$10M to support small and BIPOC food-producing farmer engagement in State Groundwater Management Act's (SGMA) Groundwater Sustainability Agencies (GSAs)
- Invests \$25M for California Underserved and Small Producers Program (CUSP) to provide financial relief to small and BIPOC farmers
- Invests \$18.75 million for small farmers within the Small Agricultural Business Drought Relief Program through Go-Biz

*Achieved in the budget*

### Food & Farm Resilience Budget Items - Support

- Fire Prevention Grants, including prescribed grazing projects and infrastructure (\$80M)
- Multi-benefit Land Repurposing Program (\$40M)
- Climate Smart Land Management Program (\$14M)
- Sustainable Agricultural Lands Conservation Program (\$25M, + continuous GGRF appropriation)
- Healthy Soils Program (\$85M)
- State Water Efficiency and Enhancement Program (\$110M)
- Dairy Methane Programs (\$83M, with specific investments in alternative manure management program)
- Conservation Management Planning Program (\$22M with \$7M set aside for organic transition plans)
- Integrated Pest Management (\$3.75M + \$1.075M for integrated pest management technical assistance)

## Partial Win

### AB 2499 (Maienschein) Organic Transition Pilot Program - Support

Would have created an Organic Transition Pilot Program to provide resources to farmers and ranchers, with prioritization of socially disadvantaged farmers and ranchers, to help them transition to organic farming.

*Died in Senate Agriculture, partially achieved in the budget*

# The California Food and Farm Policy Champions

In a Legislature with 120 elected officials, many champions for change to California's agriculture and food system are needed. This year we recognize **Assemblymember Steve Bennett** and **Assemblymember Buffy Wicks**, joining our growing list of honored legislators.

## 2022 Food & Farm Policy Champions

### Assemblymember Steve Bennett

Steve Bennett was elected to the Assembly in the fall of 2020, representing communities from the western part of Ventura County. Bennett kicked off his time in the state legislature championing farmworker issues, establishing the Farmworker Resource Center Pilot Grant Program to provide farmworkers and their families information and services related to labor and employment rights, education, housing, immigration, and health and human services. Last year, Bennett championed budget language to include prescribed grazing infrastructure and equipment in CalFire's Wildfire Prevention Grants Program, meaning goats, sheep or cattle can be used to manage vegetation to promote wildfire resilience and community safety with co-benefits like increased ecological and soil health and regional food and fiber production. As a member of the Assembly Progressive Caucus, he is committed to advancing and protecting justice for all Californians. In his new position as Budget Subcommittee Chair for climate and resource issues, we look forward to his leadership on key food, ag and resource investments. Assemblymember Bennett has voted in alignment with the food movement's priorities 93% of the time since his time in the legislature.



### Assemblymember Buffy Wicks

Assemblymember Buffy Wicks came to the Assembly in the fall of 2018, representing communities in the East Bay from Oakland to Richmond, including the City of Berkeley. Since her start, she has championed anti-hunger and equity issues, including authoring multiple pieces of legislation to improve CalFresh enrollment, such as a bill requiring state agency coordination to accelerate enrollment of children and families into the CalFresh program, and multiple attempts to create the California Anti-Hunger Response and Employment Training (CARET) program to support work among individuals who have been determined ineligible for SNAP. She's also been a champion on issues related to sugar sweetened beverages, introducing a bill in 2019 that was part of a package to protect the health of Californians and curb overconsumption of unhealthy sugar-sweetened beverages. She's championed anti-hunger budget requests, such as funding for CalFood. She's readily available to advocates, speaking to our Network in 2019 about equity in policy. As a member of the Assembly Progressive Caucus, she is committed to advancing and protecting justice for all Californians. Assemblymember Wicks has voted in alignment with the food movement's priorities 93% of the time since her time in the legislature.

# Scoring Methodology

This year, we scored 10 bills. Our scorecard considers policy committees, appropriations and floor votes, equally weighted. We used the original floor votes, unless otherwise noted. Votes in alignment with a CFFN position counted towards a legislator's score, while votes contradicting a CFFN position counted against a legislator's score. Abstained votes (indicated as 'NVR') are considered a no vote and scored in alignment with a CFFN position. A bonus point (equally weighted) is given for lead authors of a supported bill and/or budget item and subtracted for an opposed bill. The Governor was scored on 8 pieces of legislation this year, three bills that reached his desk and five budget items that were scored on whether or not they were included in any of his proposed or final budgets this year.
